Let us do the work for you, so you can focus on the training of your athletes.

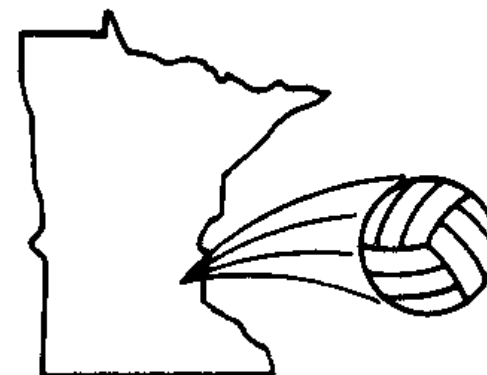

All event registration is done on-line at www.signuptoplay.com. No paper registration or emails will be accepted as registration. Instructions for registering are below.

How to register for an event on SignUpToPlay.com:

1. Go to www.signuptoplay.com
2. If necessary, create a new "Director of a Junior Club account". (Use link on home page to see if you already have an account)
3. Login using your new or existing login information.
4. Click on the 'Teams' link to create your team or teams.
5. Click on the 'Enter Events' link on the left hand side of your screen.
6. Click the button 'Enter a Team in an Event'.
7. In the Event Location select 'Minnesota'.
8. Select the event you wish to enter, the Team, and the Division.
9. Click the 'Save' button.
10. Repeat steps 6 - 9 for each team you wish to enter into an event.
11. Click on the 'Display Entry Form' to print out the registration form. Print the form for one or all teams.
12. Mail the form, release forms, and payment to the address above.
